

HOW DO I FIND FLIGHTS DEPARTING THE 186ARW?

To find out what Space A flights are available call the **186ARW Space-A Information line at 601-484-9000 Option 4**. Follow the message prompts for information.

HOW MUCH LUGGAGE AM I ALLOWED?

On the larger aircraft, each passenger may check two pieces of baggage, 70 pounds each, up to 62 linear inches in size. One hand-carried bag is allowed but must fit under the seat and must be inspected upon arrival and check-in.

TRAVELERS NEED TO KNOW

Space A is just that—space that is available after all mission requirements are fulfilled. Military aircraft are subject at all times, first and foremost, to DoD mission response.

1. Have sufficient funds available to complete travel using commercial transportation if necessary.
2. Travel light; take only essentials. Do not place valuables, medicine, or important documents in your check baggage. Be sure your name and current address is on the inside and outside of your bags.
3. Wear warm comfortable clothing. **No Open-Toed, High-Heeled Shoes or Toe-Shoes!!!**
4. When traveling on a passport you may return to the CONUS only through authorized ports of entry where customs and immigration clearance is available. While you may depart the CONUS literally from any military airfield, reentry locations for passport holders are limited.

The 186ARW is not an authorized port of entry for Space A travelers.

WHO'S ELIGIBLE?

The following are those eligible to travel Space A and the necessary documentation that is required. Please have them ready for review when signing up for travel:

- Active Duty Uniformed Services Member (includes National Guard and Reserve members on active duty in excess of 30 days and Cadets and Midshipmen of the U.S. Service Academies): Valid Military ID, and a valid leave authorization or evidence of pass status. Dependents must have Dependent ID Card
- Retired Uniformed Service Members: Valid Military ID Card (Retired)
- National Guard and Reserve Members: Authorized Reserve Component Members (National Guard and Reserve). Must have a Valid Military ID Card and DD Form 1853, *Authentication of Reserve Status for Travel Eligibility and may only travel to/from eligible destinations* IAW DOD 4515.13R
- Gray Area Retirees (Retired Reservists Entitled to Retired Pay at Age 60): Valid Military ID Card (Retired) NOTE: Gray Area Retirees are only authorized to travel within the Continental US (CONUS) and directly between the CONUS and Alaska, Hawaii, Puerto Rico, US Virgin Islands, Guam, and American Samoa. Dependents are ineligible for travel.
- On Active Duty for 30 Days or Less: Valid Military ID Card and orders placing the Reservist on active duty and a valid evidence of pass status.

- ROTC, Nuclear Power Officer Candidate (NUPOC), and Civil Engineer Corps (CEC) Members: When enrolled in an advanced ROTC, NUPOC, or CEC course or enrolled under the financial assistance program: Valid Military ID Card and DD Form 1853.
- Dependent Family Members of Deployed Uniformed Services Members: Unaccompanied command sponsored dependents of deployed active duty service members are authorized to travel when the deployment orders are for at least 30 consecutive days or more (Cat IV), or over 365 days (bottom of Cat III). Travel must commence no earlier than the first day of the deployment orders and must complete by the last day of the deployment orders: Deployment verification letter signed by the member's commander to the passenger terminal; DD Form 1173, *United States Uniformed Services Identification and Privilege Card*.
- EML Travelers: Travel orders issued by the Unified Command. Participants of the EML program may take no more than two trips per year and may not be taken within 6 months of the beginning or end of the service.

WHERE CAN I FLY TO?

Now that I have determined that I am eligible to fly where can I go?

Uniformed Service Members: C-C, C-O, O-O, O-C
Retired Uniformed Services: C-C, C-O, O-O, O-C
Dependents of Retired accompanied by their Sponsor: C-C, C-O, O-O, O-C
Reserve Component Members: C-C
Retired Reserve Members under 60 (Dependents ineligible until Sponsor is 60): C-C
Unaccompanied Dependents of Deployed Service Members, including Guard and Reserve: C-C, C-O, O-O, O-C

C = Continental United States (CONUS)

O = Outside Continental United States (OCONUS)

Alaska, Hawaii, Puerto Rico, US Virgin Islands, Guam, and American Samoa are considered CONUS

HOW DO I SIGN UP?

To sign up for Space A, you will need to fill out an AMC IMT 140 Space Available Request form, which can be obtained from the internet or you may download one yourself from the AMC travel website listed on this brochure.. You can sign up in person, by fax, or by e-mail listed on the reverse side of this brochure.

NOTE: You will need to have all required documentation to verify eligibility at time of Roll Call.

To sign up in person come to the 186ARW main gate and have the Security Guard direct you to the Aerial Port building. We are located in building 705 Northwest corner entrance.

To sign up by fax the number is **601-484-9029**. If using fax, call **601-484-9970** within two days after fax was sent to verify fax was received.

To sign up by e-mail you may send your completed AMC IMT 140 to:

Active Duty members may sign up on the first day of their leave or pass and will be kept on file until the leave or pass expires, or manifested on a DOD flight, whichever comes first.

Guard/Reserve members may sign up on the first day of their flight eligibility found on DD Form 1853 in Block 10. It will be kept on file for 60 days or until manifested on a DOD Flight, whichever comes first.

Retired members can sign up anytime and will be kept on file for 60 days or until manifested on a DOD flight, whichever comes first.

NOTE: All passengers are required to be travel ready at the start of Roll Call/Show Time.
